

# - REGULATIONS -

Participating in the Festival implies your acceptance of the following regulations.

Submission deadlines: **March 15<sup>th</sup>, 2022** for 2021 copyrighted films **June 1<sup>st</sup>, 2022** for 2022 copyrighted films

- Films received will be eligible for and considered for **all programmes** (except Young Audience programmes).

- **Only live-action fiction films** that are **debut films or film school productions** are selected for Festival programmes (except Young Audience programmes).

- Animation films are only selected for Young Audience programmes.

- Only **debut and European school films** will be considered for the European competition.

- The French competition is only for **French debut and school films**.

- Only debut and school films **made or produced in Brittany**, France, will be considered for the Breton competition.

## REGISTRATION

**1.** The Festival is open to all producers and directors of short-length films, provided **the entry is a European production, i.e. produced or coproduced within one of the following 38 MEDIA countries**: Albania, Austria, Belgium, Bosnia and Herzegovina, Bulgaria, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Georgia, Germany, Greece, Hungary, Iceland, Ireland, Italy, Latvia, Lithuania, Luxembourg, Macedonia, Malta, Moldavia, Montenegro, the Netherlands, Norway, Poland, Portugal, Romania, Serbia, Slovakia, Slovenia, Spain, Sweden, Tunisia, Ukraine - or Switzerland and United Kingdom.

2. The films must be: **video format** (the only formats accepted for screening will be DCP and HD) with a maximum running time of 30 minutes to be considered for the official competition, copyright 2021 or 2022 and must not have been registered in a previous edition of the Brest Festival.

**3.** Entry forms should be submitted **before March 15<sup>th</sup>, 2022** for 2021 copyrighted films and **before June 1<sup>st</sup>, 2022** for 2022 copyrighted films.

### **SELECTION PROCESS**

**5.** The festival selection committee pre-view films. The outcome of this pre-view is transmitted to the producer or other contact person who registered the film.

6. The pre-selected films will be kept for the festival archives and can be presented at the **Film Market**.

# THE FILMS SELECTED FOR THE FESTIVAL

7. Once the selection process is over, the films selected to enter the festival will be announced by e-mail on the 31<sup>st</sup> August 2022 at the latest. The full programme will be published online (www.filmcourt.fr) in September 2022.

8. The copies of the selected films must be sent to the address given by the festival print manager.

### **SCREENING PROCESS**

**9.** The **shipping costs** of the film copy to the festival or to any collection points will be covered by the sender. The forwarding charges for return will be covered by the Festival. The film copy may be sent via internet after agreement with the Festival organisation.

**10.** In case of damage or loss of material between reception and reshipment of the films, the liability of the festival cannot exceed at the most the cost of reprinting the film. Any **claims concerning damage to a copy** following the festival must be made within the two weeks period after the festival, up until the 1<sup>st</sup> December 2022 at the latest.

### **USAGE AND BROADCASTING OF FILMS**

**11.** Participants hand over the right to Côte Ouest to broadcast or copy extracts and/or stills from their films selected for the Festival for free, via any type of televisual media, including analogue, digital, cable, satellite and ADSL, on the internet and via all forms of paper, electronic and/or digital media.

The aforementioned extracts will not exceed 10% of the duration time of the film and will be **limited to 3 minutes in all cases**. The extracts will be used solely in the context of news items concerning the festival, internet and TV programmes, internet and TV interviews and/or publicity for the current Festival or any future Festivals.

Participants also authorise Côte Ouest to create and broadcast **a video montage of extracts** from several selected films on any form of media for the purpose of publicity, in France and abroad.

# THE JURY / THE AWARDS

**12.** The **jury** will be made up of figures from the film industry, audiovisual industries and from the media.

**13.** The **prizes** for festival award winners are donated by short film industry professionals and prestigious technical partners.

### **IN FINE**

**14.** The court of the Tribunal de Grande Instance de Brest will be the sole arbitrator, should any legal dispute concerning these regulations occur.
